## Future of Work at the Human-Technology Frontier: Core Research

**Project description**: The specific objectives of the Future of Work at the Human-Technology Frontier program are to (1) facilitate multi-disciplinary or convergent research that employs the joint perspectives, methods, and knowledge of behavioral science, computer science, design, economics, engineering, learning sciences, research on adult learning and workforce training, and the social sciences; (2) support deeper understanding of the societal infrastructure that accompanies and leads to new work technologies and new approaches to work and jobs, and that prepares people for the future world of work; (3) encourage the development of a research community dedicated to designing intelligent technologies and work organization and modes inspired by their positive impact on individual workers, the work at hand, the way people learn and adapt to technological change, creative and inclusive workplaces (including remote locations, homes, classrooms, or virtual spaces), and benefits for social, economic, educational, and environmental systems at different scales; (4) promote deeper basic understanding of the interdependent human-technology partnership to advance societal needs by advancing design of intelligent work technologies that operate in harmony with human workers, including consideration of how adults learn the new skills needed to interact with these technologies in the workplace, and by enabling broad and diverse workforce participation, including improving accessibility for those challenged by physical or cognitive impairment; and (5) understand, anticipate, and explore ways of mitigating potential risks including inequity arising from future work at the human-technology frontier.

**Eligibility**: Non-profit, non-academic organizations: Independent museums, observatories, research labs, professional societies and similar organizations in the U.S. associated with educational or research activities. -Institutions of Higher Education (IHEs) - Two- and four-year IHEs (including community colleges) accredited in, and having a campus located in the US, acting on behalf of their faculty members.

# Computer and Information Science and Engineering Minority-Serving Institutions Research Expansion Program

**Project description**: With this solicitation, the National Science Foundation's (NSF) Directorate for Computer and Information Science and Engineering (CISE) is launching a new, focused program to support research expansion for Minority-Serving Institutions (MSIs). The goal of the CISE-MSI program is to broaden participation by increasing the number of CISE-funded research projects from MSIs. MSIs are central to inclusive excellence: they foster innovation, cultivate current and future undergraduate and graduate computer and information science and engineering talent, and bolster long-term U.S. competitiveness.

**Eligibility**: Proposals may only be submitted by the following: -Institutions of Higher Education (IHEs) - Two- and four-year IHEs (including community colleges) accredited in, and having a campus located in the US, acting on behalf of their faculty members.

**Application Due date**: Apr 15, 2021

## Health

### **Rural Communities Opioid Response Program – Implementation**

**Project description**: The Rural Communities Opioid Response Program (RCORP) is a multi-year initiative by the Health Resources and Services Administration (HRSA) aimed at reducing the morbidity and mortality of substance use disorder (SUD), including opioid use disorder (OUD), in high risk rural communities. This notice announces the opportunity to apply for funding under RCORP-Implementation. This funding opportunity, RCORP Implementation, will advance RCORP's overall goal by strengthening and expanding SUD/OUD prevention, treatment, and recovery services to enhance rural residents' ability to access treatment and move towards recovery.

**Eligibility**: Eligible applicants include all domestic public or private, non-profit or for-profit entities, including faith-based and community-based organizations, tribes, and tribal organizations.

## Service Area Competition

**Project description**: This notice announces the opportunity to apply for funding under the Health Center Program's Service Area Competition (SAC). The Health Center Program supports public and private nonprofit community-based and patient-directed organizations that provide primary health care services to the Nation's medically underserved populations. The purpose of the SAC notice of funding opportunity (NOFO) is to ensure continued access to comprehensive, culturally competent, quality primary health care services for communities and populations currently served by the Health Center Program.

**Eligibility**: Special district governments, Public and State controlled institutions of higher education, Nonprofits having a 501(c)(3) status with the IRS, other than institutions of higher education, Native American tribal governments (Federally recognized), City or township governments, Independent school districts, Public housing authorities/Indian housing authorities Others (see text field entitled "Additional Information on Eligibility" for clarification), Native American tribal organizations (other than Federally recognized tribal governments) Private institutions of higher education, County governments

## **Community Food Projects Competitive Grant Program**

**Project description**: In FY 2020 and FY 2021, NIFA's CFP intends to solicit applications and fund two types of grants. The types are entitled (1) Community Food Projects (CFP) and (2) Planning Projects (PP). The purpose of the CFP is to support the development of projects with a one-time infusion of federal dollars to make such projects self-sustaining. CFPs are designed to create community-based food projects with objectives, activities and outcomes that are in alignment with Community Food Projects Competitive Grants Program (CFPCGP) primary goals. The purpose of a Planning Project (PP) is to complete a plan toward the improvement of

community food security in keeping with the primary goals of the CFPCGP. PPs are to focus on a defined community and describe in detail the activities and outcomes of the planning project.

#### **Value-Added Producer Grant**

Project description: The objective of this grant program is to assist viable Independent Producers, Agricultural Producer Groups, Farmer and Rancher Cooperatives, and Majority-Controlled Producer-Based Businesses in starting or expanding value-added activities related to the processing and/or marketing of Value-Added Agricultural Products. Grants will be awarded competitively for either planning or working capital projects directly related to the processing and/or marketing of value-added products. Generating new products, creating and expanding marketing opportunities, and increasing producer income are the end goals of the program. All proposals must demonstrate economic viability and sustainability to compete for funding. Eligibility: Independent Producers, Agricultural Producer Groups Farmer or Rancher

Cooperatives, or Majority-Controlled Producer-Based Business

## Supporting Effective Interventions for Adolescent Sex Offenders and Children With Sexual **Behavior Problems**

**Project description**: This solicitation provides funding to develop intervention and supervision services for adolescent sex offenders and children with sexual behavior problems, and to provide treatment services for their victims and families/caregivers.

Eligibility: Native American tribal organizations (other than Federally recognized tribal governments), County governments, Private institutions of higher education Nonprofits that do not have a 501(c)(3) status with the IRS, other than institutions of higher education, For profit organizations other than small businesses, Public and State controlled institutions of higher education, State governments, City or township governments, Native American tribal governments (Federally recognized), Nonprofits having a 501(c)(3) status with the IRS, other than institutions of higher education

## **Harold Rogers Prescription Drug Monitoring Program (PDMP)**

**Project description**: The Harold Rogers Prescription Drug Monitoring Program (PDMP) enhances the capacity of regulatory and law enforcement agencies and public health officials to collect and analyze controlled substance prescription data and other scheduled chemical products through a centralized database administered by an authorized agency.

**Eligibility**: State governments, City or township governments, County governments

## Implementing the PREA Standards, Protecting Inmates, and Safeguarding Communities

**Project description**: The Prison Rape Elimination Act (PREA) directs DOJ to provide grants to jurisdictions and agencies nationwide to "protect inmates (particularly from prison rape) and to safeguard the communities to which inmates return." 34 U.S.C. § 30305(a).

**Eligibility**: City or township governments, State governments, Native American tribal governments (Federally recognized), County governments

**Application Due date**: Mar 23, 2021

## **Research and Evaluation of Trafficking in Persons**

**Project description**: With this solicitation, NIJ continues to build upon its research and evaluation efforts to better understand, prevent, and respond to trafficking in persons in the United States. Applicants should propose research projects that — first and foremost — have clear implications for criminal justice policy and practice in the United States. With this solicitation, NIJ seeks proposals for research projects addressing the following priority areas: Demand reduction research, Human trafficking research, evaluation and development, Sex trafficking of American Indian and Alaska Native girls and women research.

**Eligibility**: City or township governments, Nonprofits having a 501(c)(3) status with the IRS, other than institutions of higher education, Small businesses, Independent school districts, Public and State controlled institutions of higher education, Private institutions of higher education, For profit organizations other than small businesses, State governments, Native American tribal governments (Federally recognized), Special district governments, Public housing authorities/Indian housing authorities, Nonprofits that do not have a 501(c)(3) status with the IRS, other than institutions of higher education, Native American tribal organizations (other than Federally recognized tribal governments), County governments

## **Arts and Culture**

#### **Fellowships Open Book Program**

**Project description**: The National Endowment for the Humanities (NEH) Office of Digital Humanities, in partnership with the NEH Division of Research Programs, is accepting applications for the Fellowships Open Book Program. This limited competition aims to award publishers a \$5,500 grant to release open access digital editions of books whose underlying research was funded by one of the following six NEH programs: Fellowships; Awards for Faculty at Hispanic-Serving Institutions; Awards for Faculty at Historically Black Colleges and Universities; Awards for Faculty at Tribal Colleges and University; Fellowships for Advanced Social Science Research on Japan; or Public Scholars. Each ebook shall be released under a Creative Commons license, making those books free for anyone to download. The book could

be a forthcoming title (to be open access upon first release) or it could be a book that was first released at any time during or after calendar year 2018. This program utilizes a greatly streamlined application process; there are three deadlines per year.

#### **Adult Drug Court and Veterans Treatment Court**

**Project description**: The Adult Drug Court and Veterans Treatment Court (ADC and VTC) Discretionary Grant Program provides financial and technical assistance to states, state courts, local courts, units of local government, and federally recognized Indian tribal governments to implement and enhance the operations of adult drug courts and veterans treatment courts.

Eligibility: Native American tribal governments (Federally recognized)
