Rep. Henry Cuellar Supports Partnerships with Mexico & Central America

Providing Foreign Aid and Law Enforcement Resources to the Region

Rep. Cuellar is the Co-Chairman of the U.S.-Mexico Interparliamentary Group.

- Ensuring that the essential U.S.-Mexico bilateral relationship remains strong and effective today and into the future.
- Supporting America's economic, cultural and security interests, while maintaining critical diplomatic relationship with our southern neighbor.

Rep. Cuellar helped secure \$750,000,000 to implement the *United States Strategy for Engagement in Mexico and Central America*, in 2015.

- Supporting the "Plan of the Alliance for Prosperity in the Northern Triangle of Central America."
- Helping to reduce illegal immigration to the United States.
- Bolstering regional governance, prosperity, and security.

Rep. Cuellar helped establish the High-Level Economic Dialogue (HLED) between the U.S. and Mexico.

- Flexible platform intended to advance strategic economic and commercial priorities central to promoting mutual economic growth, job creation, and global competitiveness.
- Facilitating dialogue and joint initiatives organized around three broad pillars: 1) Promoting Competitiveness and Connectivity; 2) Fostering Economic Growth, Productivity, and Innovation; and 3) Partnering for Regional and Global Leadership.

Active / Passed Legislation

Rep. Cuellar <u>Helped Lead the Passage</u> of the *United States-Mexico-Canada Agreement (USMCA) of 2019*. [Passed into Law]

- Trilateral free trade agreement that will expand opportunities for American businesses, workers, and farmers.
- Agreement is creating more balanced, reciprocal trade supporting high-paying jobs for Americans and grow the North American economy.
- It is supporting a 21st Century economy through new protections for U.S. intellectual property and ensuring opportunities for trade in U.S. services.

Rep. Cuellar is the <u>Author</u> of the *North American Development Bank (NADBank) Improvement Act of 2019*. [Added to USMCA] [Passed into Law]

- Doubles the capital reauthorization for the North American Development Bank (NADB) to \$6 billion.
- NADB provides financial support for the development and implementation of infrastructure projects to help preserve, protect, and enhance the environment at the borders.
- A new authorization of \$215 million to fund this capital increase was included in the FY20 appropriations bill for the purpose of providing immediate assistance to border communities.
- An additional \$250 million in funding was secured through the United States-Mexico-Canada Agreement (USMCA).

Rep. Cuellar is the <u>Author</u> of the *United States-Mexico Electricity Exchange Act*. [Introduced in the House]

- The Secretary of Energy is directed to work with the appropriate representatives of the Government of Mexico to establish a United States-Mexico Electricity Exchange Initiative to promote the interconnection of electric transmission facilities between the southern border States of the United States and Mexico.
- The Secretary of Energy is directed to conduct a study on the opportunities and obstacles to cross-border trade of electricity; strengthen electric grid resilience and reliability in the border region; promote the

generation and exchange of electricity in the border region; and strengthen the economic conditions in the border region.

Rep. Cuellar is the <u>Author</u> of the *United States-Mexico Tourism Improvement Act of 2021*. [Introduced in the House]

- Directs the Department of State to emphasize bilateral and corporative tourism policies with Mexico.
- Promotes U.S.-Mexico tourism initiatives, while encouraging U.S. and Mexican nonprofit groups and the private sector to support entrepreneurship development.

Rep. Cuellar is the <u>Author</u> of the *United States-Mexico Economic Partnership Act of 2019*. [Passed into Law]

- Directs the Department of State to develop a strategy to enhance economic cooperation and expand professional and educational exchange programs between the United States and Mexico.
- Encourages more academic exchanges between the countries, as well as exchanges to encourage strengthening business skills and entrepreneurship.

Rep. Cuellar is the <u>Author</u> of the Western Hemisphere Resource Assessment Amendment – NDAA 2020 [Passed into Law]

- Directs the Department of Defense, in collaboration with the Department of State and the United States Agency for International Development, to assess U.S. funding and resource allocations in the region.
- The assessments focus on investments made by China, Iran, and Russia in the Western Hemisphere.

FY22 Agriculture & Rural Development Appropriations Provisions

Rep. Cuellar <u>secured</u> language directing USDA's Foreign Agricultural Service (FAS) to develop agricultural working groups with its counterparts in Central America and Mexico.

- Improving the efficiency of the agricultural inspection process.
- Addressing agricultural trade facilitation issues.

FY22 Energy & Water Development Appropriations Provisions

- \$4,000,000 to supplement activities related to harmful algal blooms and directs the Corps to target freshwater ecosystems.
- \$5,600,000 for the Army Corps of Engineers to develop next-generation ecological models to aid in algal bloom detection, prevention, and management techniques.
- \$8,000,000 for to supplement activities related to harmful algal bloom research and control.

FY22 Homeland Security Appropriations Provisions

- Will interdict the flow of firearms and illicit currency that fund criminal organizations.
- Includes commitment to scanning 100% of commercial and passenger vehicles entering the U.S. at land ports of entry along the border.

FY22 Interior & Environment Appropriations Provisions

Rep. Cuellar helped secure \$26,739,000 to research containment strategies to combat Harmful Algae Blooms and the Spread of Sargassum.

- \$26,739,000 for Environmental Health programs, including funding for Contaminant Biology research, through the United States Geological Survey (USGS) for research on the impacts of unconventional oil and gas.
- Increase of \$1,000,000 above the budget request in Toxic Substances Hydrology for harmful algal bloom research.

Rep. Cuellar secured \$35,000,000 for U.S.-Mexico Border EPA State and Tribal Assistance Grants.
