

### **Federal Funds for Well Plugging**

Creating New Jobs and Protecting the Environment

#### **Methane Emissions Reduction Program**

This Environmental Protection Agency program was created by the Inflation Reduction Act to reduce methane and other greenhouse gas emissions from petroleum and natural gas systems. Funds can be used for permanently shutting in and plugging wells.

• Funding Amount: \$1,550,000,000 to remain available until September 30, 2028.

Eligible recipients: States, Counties, Cities/Townships, Special Districts, Territories, Tribal Governments, Institutions of Higher Education, Nonprofits, Small Businesses, Businesses (other than small businesses), and Individuals.

#### **Orphaned Well Site Plugging, Remediation, and Reclamation Programs**

The Bipartisan Infrastructure Law provided \$4.7 billion for three new programs at the Department of the Interior:

- \$250 million for wells on federal lands
- \$4.3 billion for wells on state and private lands
- \$150 million for wells on Tribal lands.

Eligible recipients: Federal, State, and Tribal Governments

#### **Funding for Texas**

Texas received \$25 million in initial funds in August 2022 and anticipates receiving \$82,563,000 in the first allocation of formula grant funds in 2023.

- Texas is estimated to receive approximately \$218,695,000 in multiple rounds of formula grant funds, for a total amount of \$343,695,000 in federal funding.
- Funds are awarded to the Texas Railroad Commission for its existing State managed Plugging Program.


These funds for oil well plugging will create an estimated <u>5,000 jobs</u> in Texas.
